# Questions and Answers about MOUNT OLIVET ROLLING ACRES

## What is Mount Olivet Rolling Acres?

Mount Olivet Rolling Acres (MORA) is a nondenominational, nonprofit organization providing high-quality support, care, and services for 1,000 adults with developmental and other disabilities.

In the late 1960s, parents of children with developmental disabilities approached Mount Olivet Lutheran Church to take over their summer camp. They gifted their property on Schutz Lake near Victoria, Minnesota, and the church promised to continue its use for people with disabilities. In 1969, MORA dedicated a new facility.

Today most of the people served are from the Twin Cities metro area. The Metropolitan Crisis Coordination Program serves people in the seven-county metropolitan area.

## Where is Mount Olivet Rolling Acres?

Our corporate offices are in Chanhassen. We operate 33 community homes located throughout the Twin Cities metro area. We also serve individuals living in their own homes as well as offer day programming, crisis support, and case management services.

## How does the Golf Scramble benefit Mount Olivet Rolling Acres?

In the 29 years since this charity tournament began, the generously donated funds have had a meaningful impact on the lives of persons with developmental disabilities. Funds have supported community homes, crisis services, recreation, and other programs that enhance the lives of the people we serve.

will be used for life enhancements for the people we serve.
